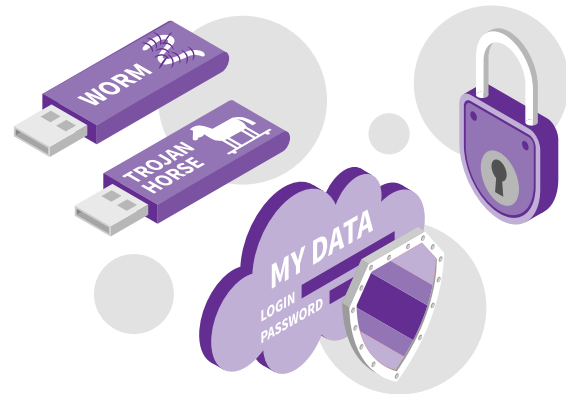


# Cyber Security
